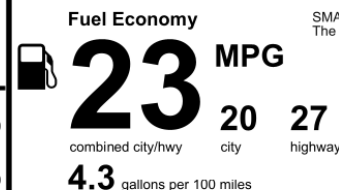

Gasoline Vehicle



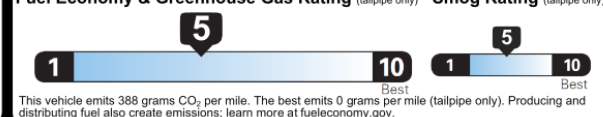
